Vendor Information:

1. All applicants will be selected by the East Bethel Booster Days committee.
2. The application and waiver must be signed to be considered for acceptance to the festival.
3. There will be no refund of vendor fees as this is a fundraiser for the operation on the East Bethel Booster Days event. Exceptions may be made to refund rules at the discretion of the East Bethel Booster Days committee.
4. The space that is available is approximately 10'x10'. This is an outdoor event. The East Bethel Booster Day committee does not provide any electricity, tents, tables or chairs.
5. Booths should have neat, tasteful and appropriate displays that appeal to all ages.
6. A Certificate of Liability Insurance listing the following as ADDITIONAL INSURED: East Bethel Booster Days and the City of East Bethel. 2241 221st Ave NE East Bethel, MN 55011. If you are unable to obtain your own certificate of liability insurance, please indicate that you would like to be included in our event coverage. If you do not provide coverage there is an additional \$20 fee.
7. Vendor Fee for Non-Food Vendors (Businesses, Direct Sales, Artists, etc.): \$25 before 5/31/2024, \$30 after 5/31/2024. Proof of liability coverage is required. If you do not carry your own liability insurance, please add an additional \$20 to your vendor fee.
